NATALIE BLAZER: Welcome to Admissible. I'm Dean Natalie Blazer. And you just heard from some of the 312 admitted students, who came to visit UVA Law for our annual open house a few weeks ago. While we absolutely love when admitted students are able to come to Charlottesville and get to know UVA Law through events like our open house, we know that not everyone can make it, and not everyone's been admitted yet.

So in this episode, I want to share a little taste of what it's like to be at our admitted students open house. I took a mini microphone around all day with me for both days of open house and talked to a ton of our admitted students, current students, faculty, and even a few proud parents, siblings, spouses, and even a baby.

JESSICA: I think so. He's really ready to get his law degree right now.

NATALIE BLAZER: All right, have fun, guys. I'm going to go find a napkin for my hand. I'm just kidding.

JESSICA: [LAUGHS]

NATALIE BLAZER: Have fun.

NATALIE BLAZER: Have fun.

[CHATTERS]

Would you guys like to be on the podcast? All right. And tell us your name, where you're visiting from.

MADISON: All right. I'm Madison. I'm from Los Angeles.

NATALIE BLAZER: And with Madison is?

MADISON: Her dad, Joel, from Los Angeles as well.

NATALIE BLAZER: From Los Angeles, and wearing a Virginia hat.

JOEL: Because I graduated in 1990.

NATALIE BLAZER: Ohhh! I love it. I love it. What are you guys most excited about?

NATALIE BLAZER: And what are you most excited about besides the bagels?

ELLIOT: Just getting to the school and the people. Yeah.

NATALIE BLAZER: Awesome. Well, welcome. We're excited to have you.

NATALIE BLAZER: Amazing. Hey. Spread the word. Thomas Frampton, do you want to be on the podcast quickly? Just say hi and where you're visiting from.

NATALIE BLAZER: Thank you, Thomas. Professor Frampton, what do you teach here at the law school? THOMAS: So I do criminal law, criminal procedure, and civil rights litigation are kind of the main classes I teach, but then also various other seminars related to crime stuff. Yeah.

NATALIE BLAZER: Awesome. Thanks for stopping by.

After checking in with some of our admitted students and guests at registration, I headed over to the Student Activities Fair, where our current law students set up on the lawn on a beautiful spring day to share with our admitted students what student organizations at UVA Law are all about. You're going to hear from the Asian Pacific American Law Students, Association, which we call APALSA.

You'll also hear from some of our Black Law Students Association representatives, which we call BLSA, followed by LALO, which stands for the Latin American Law Organization. I know we use a lot of acronyms at UVA Law so I wanted you all to who I was speaking to at the student activities fair. [CHATTERS]

All right this is Dean Blazer at the Student Activity Fair. I'm here with APALSA. Tell us your name and what you're excited about today.

JUNI: I'm Juni. I'm excited to meet prospective students and tell them about my love for Charlottesville.

NATALIE BLAZER: Awesome.

WES: I'm Wes. Really excited to see the new generation. I'm really excited that APALSA is also kind of in a growing stage right now. And we're really excited to meet new students.

NATALIE BLAZER: Love that. And here I am at the next table over from APALSA. BLSA, tell us your name and what you're excited about today.

JARED: Hello, I am Jared. I'm a 2L. And like I'm just excited to meet new people. I think it'll be fun. NATALIE BLAZER: Yeah.

LAURA: Hi. My name is Laura Louise. I'm also a 2L. I'm just excited to be in some really good weather while meeting people today. It's so nice out.

NATALIE BLAZER: It is beautiful. It is beautiful. Oh, I'm here with LALO and their fresh beats. LUIS: Yeah.

LUIS: My name is Luis. I am super excited to just get to know new faces. People coming to our community next year and just getting excited about having and growing as a community and be able to share with others our passion and love for being Hispanic and having a good strong community here. Yeah.

RAQUEL: I'm Raquel. I'm very excited about our growing community, especially as we're doing a lot more events with I think like the wider school, like sharing our great music taste. So looking forward to sharing more of our things with everyone.

NATALIE BLAZER: I love it.

ALEJANDRA: I'm Alejandra. And I'm excited about showing the new students, prospective new students that we're here and we have a place in this community. And we're thriving, and that they can thrive, too, if they come to UVA.

NATALIE BLAZER: Amen. Thank you all for being here, and look at this delicious candy.

NATALIE BLAZER: The next table at the Student Activity Fair, Common Law Grounds. Tell us your name, what year you are, and what this organization is all about.

KRISTEN: I'm Kristen. I am a 2L. And Common Law Grounds is all about bringing people, who might not agree with each other on a particular topic and bringing them together over a meal to discuss their differences and discuss their viewpoints. And we have different topics every month. And we are super excited to share about our org with these admitted students.

NATALIE BLAZER: Amazing. Thank you both for your work that you're doing. Hello. Can you tell us your name and what your organization is all about?

CALVIN: So my name is Calvin Wirfel. I'm the President of the Virginia Law Veterans.

CALVIN: We're basically just here to provide a space for veterans, to provide veteran-related activities, networking events, social events, things like that to build the veteran community here at the law school. NATALIE BLAZER: Thanks so much, Calvin.

CALVON: Thank you.

NATALIE BLAZER: This is Dean Blazer. I'm here with the Plaintiffs Law Association, PLAVA. And tell us your name and what this organization means to you.

ANNIE: Yeah. Hey, I'm Annie Somerville. And I'm a 3L. And I think when you get to law school, you hear a lot about public service and big law. And nobody really talks about plaintiffs law. So we're just increasing awareness and having speakers come in to tell us what they do.

NATALIE BLAZER: And what are you most excited about for open house today?

ANNIE: Yeah. I'm just excited to see their faces and tell them what an awesome place this is. I envy that they're at the point that they're considering coming to school here. I wish that I could go back. It's bittersweet to see new people coming in because that means that I'm leaving, but I can't wait to talk to them about UVA.

NATALIE BLAZER: They're at the beginning of their journey, which is like, yeah, I'm definitely jealous. I'm here with Andrew Broaddus and Dawn Davison from the Public Service Career Center. I just sat in on their Public Service Career session. What'd you guys think?

ANDREW: I thought it was wonderful. We had a ton of very excited interested new students here and just seemed very excited about public service, which we're happy about.

NATALIE BLAZER: What kinds of questions did you get?

DAWN: We got a lot of questions from that last group about federal government. It seemed like a room that was full of people who were interested in working for DOJ, or one of the other agencies, or perhaps national security stuff.

NATALIE BLAZER: So if you had one piece of advice for listeners of the Admissible Podcast, who are hoping to go into public service, thinking about UVA Law, what would you tell them?

DAWN: I would tell them that we have a lot of support here. And we are looking to get as many public service students here as we can. We'd love to take over the entire school of public service students. Please help us.

NATALIE BLAZER: Rock on.

OK. I think you can tell by this point I was having a great time talking to some of our current law students and staff who gave up a lot of their time to participate in open house, which they do every year. And I'm so grateful for. But I did have so many conversations with admitted students far more than we could fit in this podcast. And I want to share a few more of those with you.

So let's jump back in on the second day of open house and hear what they had to say about UVA Law. Checking in on day two of admitted students open house here in Charlottesville, Virginia UVA Law. I'm with Maddie Winter. Hi, Maddie.

MADDIE: Hi.

NATALIE BLAZER: So what's your favorite thing about open house so far?

MADDIE: It's been great meeting all these people. I just talked to some great professors in health law, which I'm really interested in. Got to learn more about the program and it's been really a great time. We went to a brewery. It's been really fun so far.

NATALIE BLAZER: I'm here with Amanda, Aidan, and Olivia. What's y'all's favorite part of open house so far?

AMANDA: I really like the trivia. Our team name was 0Ls All Wins or All W's. Clever name.

NATALIE BLAZER: 0Ls. All W's.

AMANDA: Yeah. Yeah.

NATALIE BLAZER: I love that. AMANDA: We got fourth. So--NATALIE BLAZER: Nice.

AMANDA: We're doing pretty well.

NATALIE BLAZER: Nice.

AMANDA: [INAUDIBLE] A lot of fun.

NATALIE BLAZER: That's great. How about you, Aidan?

AIDAN: I have really enjoyed all the meaningful conversations I've had with current students, who have just been so generous and imparting wonderful, knowledgeable advice about what they would do differently, how they would make the most of your law school experience, down to where's the best place to play soccer.

NATALIE BLAZER: I love it. How about you?

OLIVIA: I really enjoyed all the sessions. I've been very impressed with how funny everyone is. I feel like every session I've gone to I've expected it to be very dry and boring, and they've all been really interesting.

NATALIE BLAZER: Just wait for the mock classes. Do you guys know which class you're going to?

OLIVIA: I think criminal.

AIDAN: Yeah. AMANDA: Yeah.

NATALIE BLAZER: Crim?

AMANDA: Yeah.

NATALIE BLAZER: [INAUDIBLE] all three of those faculty members have been here since I was a

student.

AMANDA: Oh, wow.

NATALIE BLAZER: They're amazing. I'm here with a group of admitted students catching up during our coffee break. And we're talking about corporations. You guys excited for class?

SUBJECT 1: Absolutely. ROSEANNE: Absolutely. SUBJECT 2: Definitely.

NATALIE BLAZER: Well, what was your interview like? Tell us who did you interview with.

ROSEANNE: Director Cassandra.

NATALIE BLAZER: OK.

ROSEANNE: She was very sweet and made me feel at peace [INAUDIBLE].

[INTERPOSING VOICES]

NATALIE BLAZER: I love hearing that. What about you?

SUBJECT 1: I agree with Roseanne. She was awesome. It was just such a fun conversation. She was so excited. It was so excited. It was honestly so much fun.

NATALIE BLAZER: I love that. OK. On a scale of 1 to 10, how close are you to committing to UVA Law right now?

ROSEANNE: Probably like a seven.

NATALIE BLAZER: Whoa, OK. SUBJECT 2: Maybe an eight.

SUBJECT 3: I would second the seven.

NATALIE BLAZER: OK

SUBJECT 4: 9.75.

NATALIE BLAZER: Wow. SUBJECT 5: 10 out of 10.

NATALIE BLAZER: 10 out of 10. We got a 10. I just ran into a podcast fan out here at the Student Activity

Fair. Tell us your name and where you're visiting from.

MICHAEL: My name is Michael Nablus. I'm visiting from Miami, Florida.

NATALIE BLAZER: Welcome, Michael. And what are you most excited about open house?

MICHAEL: I was excited to see the Grounds. After many, many months of looking at pictures online, I was excited to see what it looks like in person. And it is breathtaking. It's incredible.

NATALIE BLAZER: And what do you think was the most difficult part of your application process?

MICHAEL: The essays. The essays were difficult because I wanted to make sure I was responding to the prompts. And I wanted to come across the way I see myself. So I was really enthusiastic about UVA. This is where I wanted to go. So I took a lot of time. I kept reading them.

And then after I submitted them, I never looked at them again because I knew I would find something somewhere, and just have a meltdown, and pester my wife about it all night. So I was just like I didn't look at it again. So--

NATALIE BLAZER: Well, you did something right. So congratulations.

MICHAEL: And I'm going to keep listening to the podcast even after I'm going to school here. It's a lot of fun.

NATALIE BLAZER: I love it.

MICHAEL: I walk my dog at night and I listen to it.

NATALIE BLAZER: Oh. MICHAEL: And it's great.

NATALIE BLAZER: Thank you so much, Michael. Congratulations.

MICHAEL: Have a good one.

NATALIE BLAZER: Have a good one. I am here with admitted student Marin Geiger and her sister,

McKenna. Tell us what the most difficult part of the application process was for you.

MARIN: I think it's the unpredictability of the results. Because going into it, you look at your estimators, you look at what you're likely to get into and so on. And then it just so does not turn out that way.

Sometimes it does, sometimes it doesn't.

And then there's also schools that you didn't even think about would really grab your attention, and then they do. So it just really has been nothing that I've expected but I'm a strong believer that things happen for a reason.

NATALIE BLAZER: Yeah.

MARIN: So yeah.

NATALIE BLAZER: Thank you all for coming on. I just ran into one of our admitted students. Tell us your name and where you're visiting from.

BRENDAN: Hi. My name is Brendan. And I'm from Chicago.

NATALIE BLAZER: Welcome, Brendan. And who do you have here with you today?

BRENDAN: I have my mom and my dad. NATALIE BLAZER: Hello. Welcome. BRENDAN'S FATHER: Thank you.

BRENDAN'S MOTHER: Thank you. It's a great place.
NATALIE BLAZER: Oh. Is it a little warmer than Chicago?

BRENDAN'S MOTHER: A little bit.

BRENDAN'S FATHER: It is today. Yeah, for sure.

NATALIE BLAZER: So tell us a little about your application process.

SUBJECT 6: Yeah. I have been teaching for the last three years. And I was really interested in UVA for their focus on education law and policy. I listened to every single admissible podcast about tips and tricks of how to get in.

NATALIE BLAZER: Well, congratulations. We're so thrilled to have you here. I'm here in the hallway with Joshua Jolly from Clifton Park, New York. Hi, Josh.

JOSHUA: Hello, Dean Blazer. I remember from the podcast, you saying that you don't shake hands. So I wanted to come and greet you from at distance.

NATALIE BLAZER: We're standing about two feet apart. And that's perfect for me.

JOSHUA: [INAUDIBLE]

NATALIE BLAZER: And Josh, you just told me something else. And what was that?

ALLIE: Hi.

NATALIE BLAZER: Hi, guys. MR. FRAGA: Hi. Good afternoon.

NATALIE BLAZER: Tell us where you're visiting from.

MR. FRAGA: We're from Miami.

NATALIE BLAZER: And Allie, what are you most excited about open house?

ALLIE: Just to meet the amazing people here. I'm super excited. I'm committed. By the way.

NATALIE BLAZER: Ahhh!

ALLIE: Yay!

NATALIE BLAZER: Yeah. Now we need your help committing everybody else. What do you say?

ALLIE: Definitely.

NATALIE BLAZER: [LAUGHS] And what are you, as the parents, most excited about for Allie becoming a lawyer?

MR. FRAGA: Well, we feel very blessed. We feel this is the best law school in the world.

NATALIE BLAZER: I agree. I agree.

MR. FRAGA: So when she got the great news from, I think, it was Katie when [INAUDIBLE].

NATALIE BLAZER: Yeah, Katie.

MR. FRAGA: Well, I think she probably heard the shouting from here because she was so excited.

MRS. FRAGA: So thrilled.

MR. FRAGA: She was so thrilled. And we all felt so happy and so blessed. And we're very happy to be here.

MRS. FRAGA: She told us on her day of-- her birthday. She came out with the UVA cap.

MRS. FRAGA: She said I have an announcement for you, guys. I'm committed!

ALLIE: It was great [INAUDIBLE]

NATALIE BLAZER: Oh, I love it. I love it. So what piece of advice would you give to someone out there who's going through the application process or is going to be going through it?

ALLIE: Honestly, just take a deep breath and be yourself. That's the best advice I can give because honestly, I tried my best. And I am here at my dream law school. So everybody can do it.

NATALIE BLAZER: I love it. So heartwarming. Thank you all for being here.

MR. FRAGA: Thank you. It's our pleasure.

MRS. FRAGA: Thank you so much.

NATALIE BLAZER: I just ran into one of our faculty members, Josh Bowers. Professor Bowers, what was the hardest part of your law school application process? Do you remember?

JOSH BOWERS: Oh, man. Waiting for envelopes to arrive by mail and judging based upon their thickness or thinness, whether I thought I might get in or not without opening them up.

NATALIE BLAZER: [LAUGHS] I love it. Do you have a message for the next generation of UVA Law students?

JOSH BOWERS: Keep changing the world. Don't be content with the state of the law as it currently is and the state of society as it currently is. But use the skills that you develop in law school wherever you go to law school to fix what's broken and to preserve what works.

NATALIE BLAZER: I love it. Thank you so much.

JOSH BOWERS: Sure thing.

During this event, so many admitted students approached me to say that they listened to the Admissible Podcast, and that it helped them in their process. And I wanted to give those people a chance to come on the show and talk about that. And I hope for anyone listening out there who is applying or who has not been admitted I want you all to that those people were in your shoes at one point. And I hope that this podcast continues to help you in your process.

Really, admitted students open house is what our cycle is all about. It's when everything really comes together for us, meeting people in person, and getting to chat with them, and get to them better, and get to share what makes UVA Law so special.

So that this was a somewhat unusual episode. It's not our usual interview format here in the studio. But I hope that it gave you a little bit of a glimpse of what makes UVA Law and our admitted student events so special.
